

## RITA Medical Systems Announces Fourth Quarter and Full Year 2005 Earnings Release Date and Conference Call

(Nasdaq: RITA) today announced that it will release financial results for the fourth quarter and full year ended December 31, 2005, after the market close on Thursday, February 23, 2006. The Company will also host a conference call and webcast on Thursday, February 23, 2006 at 2:00 p.m. Pacific Time to discuss the Company's fourth quarter and full year results, outlook for 2006, and current corporate developments. RITA Medical Systems develops, manufactures and markets innovative products for cancer patients including radiofrequency ablation (RFA) systems for treating cancerous tumors as well as percutaneous vascular and spinal access systems. The Company's oncology product lines include implantable ports, some of which feature its proprietary Vortex® technology; tunneled central venous catheters; and safety infusion sets and peripherally inserted central catheters used primarily in cancer treatment protocols. The product line also includes the HABIB 4X resection device which coagulates a "surgical resection plane" and is designed to facilitate a fast dissection in order to minimize blood loss and blood transfusion during surgery. The proprietary RITA RFA system uses radiofrequency energy to heat tissue to a high enough temperature to ablate it or cause cell death. In March 2000, RITA became the first RFA Company to receive specific FDA clearance for unresectable liver lesions in addition to its previous general FDA clearance for the ablation of soft tissue. In October 2002, RITA again became the first company to receive specific FDA clearance, this time for the palliation of pain associated with metastatic lesions involving bone.
