Explanation of Responses:

1. This grant of 13,052 shares of common stock ("Common Stock") of AngioDynamics, Inc. (the "Company"), represents 13,052 restricted stock units, each of which represents a contingent right to receive one share of Common Stock. These restricted stock units vest in four equal annual installments beginning on May 23, 2017, such that 25% of the restricted stock units vested on May 23, 2017 and 25% of the restricted stock units will vest on each of May 23, 2018, 2019 and 2020.

2. These stock options vest in four equal annual installments beginning on May 23, 2017, such that 25% of the options vested on May 23, 2017 and 25% of the options will vest on each of May 23, 2018, 2019 and 2020.

3. Each performance right represents a contingent right to receive one share of Common Stock. The target number of shares of Common Stock is set forth in column 3 of Table II. Between 0% and 200% of the target number will be earned based on total shareholder return relative to a peer group of companies over a three-year performance period covering the Company's fiscal years 2017, 2018 and 2019. Any shares that do not vest at the end of the performance period will be forfeited.
